The Quotationer shall have to deposit a sum of Rs.10,000.00 (Rupees ten thousand) only in the form of Bank Draft/ Call Deposit from any Nationalized Bank pledged in favour of District Commissioner, Bajali to be payable at Bajali as Security Deposit, which shall be refundable on satisfactory completion of the assigned job and after the contract period is over. If the job is not executed satisfactorily as per the specifications and within the stipulated period, the District Commissioner, Bajali reserves the right of rejecting the job and no compensation will be paid for such rejection and the Security Deposit will also stand forfeited.
- 3. Quotationer should have adequate experience of videography.
- 4. Quotationer will be required to adhere strictly to the time frame and no delay will be accepted.
- 5. The Quotationer must furnish the following up to date valid documents along with their tender:
