#### Terms & Conditions-

- Rate should be quoted including GST and other taxes and valid for a period of one year from the date of opening of the tenders/quotations.
- Bidder(s) must have the capacity to supply the item immediately considering the urgency of elections.
- Payment is subject to satisfactory completion of the job. No advance payment will be made for the
  job.
- 4. Each firm shall submit photocopies of GST registration certificate, photocopy of firm registration certificate, up-to-date trade license (valid till 01-03-2025), valid PAN Card, previous experience, if any along with tender paper.
- The work may be allotted to one or more than one firms/suppliers depending upon the urgency of the work.
- 6. Preference will be given to bidders with previous experience of supply.
