Persuant to para 4.4 of the Govt Notification No. DA5R.80/2020/3 dated 20/01/2021 and as per Chief Engineer, PWD (Roads) Letter No CE//STBR/II/15/2022-23/33 dated 22/07/2024, the District Level Land Purchase Committee (DLLPC) for Bajali District, after being satisfied that for the public purpose, the land, the brief description of which is given in the schedule below, is required for acquisition for "Construction of ROB at LC Gate No. SK-34 on Bhawanipur-Manash Road" in the district of BAJALI in the state of ASSAM, hereby declares its intention to acquire such land by direct purchase.

Any person interested in the said land may, within 15 (fifteen) days (as amended vide notification no No.RLA.231013/37 dated 23/08/2023) from the date of publication of this notification, object to the use of such land for the aforesaid purpose under section 3(vi) of the said notification. Every such objection shall be made to the Chairman, DLLPC, Bajali namely, DISTRICT COMMISSIONER, BAJALI in writing and shall set out the grounds thereof and the Chairman, DLLPC shall give the objector an opportunity of being heard, either in person or by a legal practitioner, and may, after hearing all such objections and after making such further enquiry, if any, as the Chairman, DLLPC thinks necessary, by order, either allow or disallow the objections.

This notification is published for acquisition of land through direct purchase by way of negotiated settlement for construction of Road Over Bridges (ROBs) jointly by the Railways and State Government on "50:50 Cost Sharing Basis" scheme.

The land plans and other details of the land to be acquired under this notification are available and can be inspected by the interested person at the <https://bajali.assam.gov.in>, concerned Revenue Circle Office and office of the Chairman, DLLPC cum District Commissioner, Bajali.


