MINUTES OF THE DISTRICT DEVELOPMENT COMMITTEE MEETING, BAJALI
HELD ON 07/12/2022 AT 1.00 PM AT THE IB BHAWANIPUR IRRIGATION DIVISION, BAJALI LOCATED
NEAR LAOGAON SLUICE GATE.

The meeting was presided over by Smti. Cauvery Barkakati Sharma, ACS, Deputy Commissioner, Bajali and welcomed all members present.

After a brief interactive session with District Development Commissioner, Addl. Deputy Commissioner and all the members, the house started discussion on different sector wise issues as well as reviewed progress of various developmental schemes as follows.

Krishi Vigyan Kendra, Barpeta:- The Senior Scientist & Head, KVK, Barpeta informed the house about the completion of VDP, Kishan Bio Hub in collaboration with ICAR, over a period of 2 years. It shall benefit a total of 100 farmers of the district.

He also informed about the integrated farming system under NABARD which shall benefit a total 10 famers in the district.

DC, Bajali asked the Senior Scientist & Head, KVK to carry out mandated activities like training, demonstration in the district and to complete the ongoing projects on time.

(Action : Senior Scientist & Head, KVK, Barpeta)

PHE Dept. :- DC, Bajali reviewed the status of FHTC target & achievement. The E.E, i/c PHE, Bajali Division informed the house that out of the target of 29370 for the year 2022-23, achievement till last month is 1179. He also informed that already 37 schemes handed over after joint verification and 10 schemes will be handed over soon. Further, he informed that 25 new schemes have been allotted out of which 3 are completed.

DC, Bajali instructed to E.E, i/c , PHE Bajali to resolve the charging issue in PHED Bhawanipur schemes by this month.

(Action : E.E, PHE, Bajali Division & Nodal Officer, JJM, Bajali, AGM, APDCL, Bajali)

Fishery Dept.:- The DFDO, Barpeta informed the house about the ongoing Fish Feed Mill project at Hathinapur. He also informed about ongoing RIDF schemes, the shade construction has been completed & machineries are to be brought from Hyderabad.

The DFDO, Barpeta informed that the project will start from April'2023. The DFDO, Barpeta informed another Fish Feed Mill at Nityananda to be completed soon.

DC, Bajali instructed to complete the ongoing schemes within the stipulated time.

(Action : DFDO, Barpeta)

Water Resource Dept. :- The A.E.E, Bajali WR Sub-Division informed that there are a total 15 nos. of ongoing schemes in Bajali district out of which 4 are new schemes, 11 are ongoing schemes. Out of 15 nos. of schemes 6 are already completed. DC, Bajali instructed to complete the schemes by Feb'2023.

DC, Bajali informed the right bank embankment of river Pahumara, the anti erosion and bank protection works will be handled by W.R Deptt. However, all earth works for raising & strengthening of embankment is to be handled by PWD (Roads) Dept. except the breach portion at Medhikuchi (Apprx. 220 m).

(Action :A.E.E, Bajali WR Sub-Division, Pathsala & E.E, P.W.D (Roads))

PWD(TR) Dept :- The E.E, P.W,D Bhawanipur- Patacharkuchi- Sarukhetri Territorial Road Division informed that all the schemes under PMGSY has been completed except one RCC bridge Bamunkutni (Hokartup).

DC, Bajali asked E.E, P.W.D, Bhawanipur- Patacharkuchi- Sarukhetri Territorial Road Division to complete the bridge by Mar'2023.

E.E, P.W.D also informed that there are 5 nos. of ongoing road and embankment schemes in Bajali district.

DC, Bajali desired that she will personally visit all 5 schemes.

(Action : E.E, P.W.D, Bhawanipur- Patacharkuchi- Sarukhetri Territorial Road Division)

Handloom & Textiles Dept: - The Asst. Director of Handloom & Textiles, Barpeta informed the house that 14528 nos. weavers have been applied for registration in Swa Nirbhar Nari portal out of that 13677 nos. weavers have been accepted after field verification.

The Asst. Director of Handloom & Textiles, Barpeta also informed that out of 39 nos. of cooperative societies 6 nos. are activated.

DC, Bajali asked to take up the matter of dormant co-operative societies with the Government.
(Action: Asst. Director of Handloom & Textiles, Barpeta)

Excise Dept. :- DC, Bajali instructed to Deputy Superintendent of Excise, Pathsala, Bajali to conduct regular excise raid in the district with due information of schedule visit to the DC, Bajali.

DC, Bajali asked to achieved the target within the stipulated time.

Transport Dept: - DC, Bajali instructed to DTO, Barpeta & i/c Bajali to held first meeting for Skill & Driving scheme (pertaining to Bajali dist.) with representative of Guardian Minister within 7 days.

(Action: DTO, Barpeta & i/c Bajali)

A.H & Veterinary Dept.:- DC, Bajali instructed the land for District Veterinary office shall be placed in the next SDLAC meeting. The DVO will liaise with ADC, Revenue, Bajali in this regard.

(Action : ADC, Revenue, Bajali & DVO, Barpeta & i/c Bajali)

P&RD Dept. :- DC, Bajali instructed both the BDOs' to enhance the percentage of completion of PMAY(G) houses and achieve the target at the earliest.

(Action: BDO, Bajali & Bhawanipur Dev. Block)

Agriculture Dept.:- DC, Bajali instructed to the DAO, Barpeta & i/c Bajali

- The DAO will liaise with NABARD, NCDL and APART regarding setting up of FPC at Block level and submit a detail report to the DC, Bajali.
- Data segregation of PM-KISAN of Bajali district to be completed soon.
- Immediately segregate & notify the 39 nos. of villages of the four new GPs' within the Agricultural circle of Bajali district for enhancing paddy procurement.

(Action :- DAO, Barpeta & i/c Bajali)

Soil Conservation Dept.: - DC, Bajali instructed to Divisional Officer, Soil Conservation Division, Barpeta to submit an action plan for physical verification of all ongoing schemes along with District Administration, Bajali. (Action: Divisional Officer, Barpeta Soil Conservation Division, Barpeta)

Sericulture Dept.:- DC, Bajali instructed Superintendent of Sericulture, Bajali to conduct awareness meeting on Eri cultivation in Bajali district. (Action: Superintendent of Sericulture, Bajali)

DI&CC:- DC instructed to GM, DI&CC, Barpeta to call for DLC meeting for finalizing of "One District One Product" in respect of Bajali district immediately. (Action G.M, DI&CC, Barpeta)

PWD (B) Dept: - The E.E, PWD (B) Division informed that there are currently 7 nos. ongoing schemes in Bajali district.

- The land for the integrated DC, office Bajali to be handed over tomorrow i.e. on 8-Dec-22 to PWD (B) Division.
(Action: E.E, PWD (B) & NH division, CO, Bajali Revenue Circle)
- The E.E, PWD (B) Division informed that land is required for construction of District Library at Bajali and District Convention Centre at Bajali.
(Action: ADC, Revenue, Bajali, E.E, PWD (B) & NH division, CO, Bajali/ Sarupeta Revenue Circle).
- The land for Titka Garia Mini Stadium to be handed over to PWD (B) Division.
(Action: E.E, PWD (B) & NH division, CO, Circle Concerned)

Irrigation:- The E.E., Tihu division informed that there are 11 nos. of fully functioning schemes in Bajali district & 16 nos. SOPD schemes of which 8 nos. are completed.

DC, Bajali instructed to complete the remaining 8 nos. of schemes by Jan'2023.

DC, Bajali also instructed E.E, Bhawanipur Division (Irrigation) that there is a connection issue which need to be sorted out.

(Action: E.E, Bhawanipur Division (Irrigation) & AGM, APDCL, Bajali)

Social Welfare:- DC, Bajali instructed to the DSWO, Bajali to conduct medical camps for physically handicap on 10-Dec-22 & 11-Dec-22.

The DSWO, Bajali informed that the PMMVY scheme is currently halted/ stalled from the last three months in Bajali district because of non segregation of data between Barpeta & Bajali.

DC, Bajali instructed to DSWO, Bajali to submit a status report on why the process of PMMVY scheme is stalled and to complete the process of data segregation between Barpeta & Bajali by the next DDC meeting.

Education:- DC, Bajali instructed the DEEO/ Inspector of School, Barpeta & i/c Bajali to complete the construction of functional girls toilet in secondary/ elementary school as per the prescribed target.
(Action: ADC, Education, DEEO/IS, Barpeta & i/c Bajali)

In addition to the above the DC, Bajali instructed the HoDs' for compulsory participate in and extend full co-operation to the District Administration for the first "**Bajali District Day**" to be held on 12-Jan-2023. All departments should submit CM Dashboard report by 30th /31st of every month.

After threadbare discussion and review of all other departments the Deputy Commissioner urged all departmental heads to have co-ordination among all the line departments for successful implementation of all developmental schemes and requested all the members to bring any difficulties or untoward condition to the notice of District Administration for smooth disposal of the works.

The meeting ended with a vote of thanks from DDC, Bajali. The next meeting will be held at at Rihabari (Kaldia Head works Irrigation) on the bank of Kaldia river.
