## PREFACE

Flood , a common hazard to spread terror in the monsoon seasons in the region. It causes immense destruction of crops, property and even of life in the region. The floods are a common feature occurring in the region since time immemorial. These used to leave silt on the agricultural field making them fertile every year. But their intensity and destruction have increased since the great earthquake of August 15, 1950. This earthquake disturbed the courses and beds of many rivers in Assam. The nature of flood has been changing and so the extent of damage in the course of time.

In this respect , directives from the ASDMA to be well take care of. The focus lies on the preparedness of three phases of flood Pre-flood, During-flood and Post-flood.

The Sarupeta Revenue Circle has a very old history and some of the villages under the circle are flood prone. There are two nos. of rivers under the circle namely Pahumara and Palla. In the monsoon season due to the incessant rainfall volume of water overflows and breaches the existing embankments of the rivers and inundates a large areas of nearby villages.
